Data Privacy

The Hellenic American College will keep your personal information only for as long as it has legal, regulatory or contractual responsibilities to maintain this information.

You have the right to access the personal information we maintain on you and to request a copy of this information; to correct inconsistent or inaccurate and complete any missing data; to delete or to restrict the processing of this data for matters explicitly defined by law; to receive the personal data concerning you in a structured, commonly used and machine-readable format; and to object to the processing of personal data for matters explicitly defined by law or withdraw his/her consent.

You can exercise these rights by submitting a relevant written request to Hellenic American College, Massalias 22, dataprivacy@haec.gr, to which Hellenic American College must answer within one month from its receipt. This deadline may be extended for two additional months if the complexity of your request or the number of requests in general require so. If you believe that Hellenic American College has infringed your data privacy rights, you have the right to file a complaint with the Hellenic Data Protection Authority (www.dpa.gr).
